## Minute One, Ninth Month 2024

As Quakers, we believe Peace is an essential precondition for healthy Life. We believe a healthy peaceful life is a birthright of ALL humans. Our government should support conditions of Peace and Justice throughout the world wherever and whenever possible. We strongly register our disagreement with the military use of our tax dollars to support one side in current conflicts thereby perpetuating their prolongation.

We particularly object to the unconditional release of funds and armaments to Israel in the light of Israel's 2024 bombardment of Palestinian citizens, destruction of Infrastructure and exclusion of humanitarian aid. There can be no Peace in that region under this policy.

They also presented a letter (Appendix A) to local representatives on Gaza to be mailed and/or hand delivered along with an FCNL handout (<u>Call for an Immediate Ceasefire, De-escalation, and Humanitarian Access in Gaza | Friends Committee On National Legislation (fcnl.org)</u>) in meetings with staff. Meeting approves.
